


## The Ultimate Checklist for Permanent Redaction

## Automate redaction to save time and ensure that no sensitive data is missed

Manually identifying and protecting sensitive information can present difficulties, as this process is subject to human error. Each document is unique and sensitive information can easily be overlooked — a tedious process leading to costly errors.

With automated redaction, you can specify the type of information you wish to be redacted, such as **Personally Identifiable Information (PII)**, **Protected Health Information (PHI)**, social security numbers, and account numbers, letting the tool work its magic to identify the information in the document to edit or redact depending on the situation at hand.

## Ensure that sensitive information is removed permanently — not just covered up

In order for sensitive information to be fully redacted, it must be permanently deleted from the document, image, or file in which it exists.

Manually covering information, such as using a black box to hide text, is not only time-consuming, but also doesn't provide adequate redaction. A quality redaction software will completely remove text from underneath the redaction box so that the confidential information cannot be uncovered.



#### Remove metadata from files

All documents contain metadata, such as the author, date created, company name and more. Sometimes it still contains the same information that was redacted from the original file. If these sources of information are not also removed, kinadvertent disclosure of sensitive information can still occur.



## Streamline and simplify redaction with the help of pattern matching algorithms




